# **News and Notes**

The COVID-19 pandemic ended yesterday. At least the federally declared Public Health Emergency ended yesterday, but as we all know, COVID-19 still exists. As do many other Public Health threats. We'll cover a couple of those this week, plus recap the State Health Board's monthly meeting held this past Tuesday.

### State Board of Health meeting

The May meeting of the State Board of Health was the last one to be held at 2 Peachtree. Commissioner Toomey commented on many significant changes that have happened over the years, and a couple that are on the horizon. This includes the move to new offices at the Twin Towers, the ending of the Public Health Emergency declaration, and the announcement from CDC Director Dr. Rochelle Walensky that she is stepping away from that position next month. Dr. Chris Rustin told board members that the end of the COVID-19 declared emergency will bring some changes, but vaccinations, testing and treatment will continue. Data reporting requirements will be less stringent. He said COVID cases have dropped 92% since the height of the Omicron variant, and similar declines have also occurred in hospitalizations and deaths.

# TikTok Prohibition (SB93)

William Bell presented the board with appropriation levels for the coming fiscal year. Material and childhood health is a focus both legislatively and financially for the coming fiscal year. There will not be a state health board meeting in June. The next meeting will be held July 11.
